

- FAIR GOOD EXERNIT
- Not referred for diagnostic testing
- Infant not sleeping for appt
- Middle ear disease causes delay
- Referral to ENT/PCP without return to audiology
- Complex medical status
- Insufficient or inefficient audiologic protocol












# IMPACT at Diagnostic Sites across Ohio








# IMPACT at Diagnostic Sites across Ohio

### Collaborative Process

- Invitation to audiologists to review COACH protocol for consistency with JCIH (2019) and other evidence
- 20+ audiologists worked together for the entire year through monthly Audiology Work Group virtual meetings and Section break-out groups

Call to Action (January 2022)

# Literature and Protocol Review (March-July)

- Reviewed JCIH (2019) thoroughly to evaluate recommended changes
- Also included other evidence as indicated and articles that have been published since 2019

- Section Break-out Groups revised specific aspects of the protocol
- The entire AWG committee reviewed recommended changes to build consensus

# Recommended Protocol for Diagnostic Audiological Assessment Follow-up to Newborn Hearing Screening in Ohio (Rev. 2022)

The Early Hearing Detection and Intervention (EHDI) Program at the Ohio Department of Health (ODH) and the Coalition of Ohio Audiologists and Children's Hospitals (COACH) formed a taskforce in 2015 to establish standardized diagnostic evaluation measures for infants who did not pass their newborn hearing screening. The outcome was a diagnostic protocol focusing on the first 3 months after birth, in which the diagnostic process should be completed. The protocol was designed to assist audiologists to comply with best practice for optimal universal hearing loss detection and intervention (EHDI) goals. The original protocol was endorsed by the ODH Universal Newborn Hearing Screening Subcommittee in August 2016. Subsequently, the Joint Committee on Infant Hearing (JCIH) released the Year 2019 Position Statement: Principles and Guidelines for Early Hearing Detection and Intervention Programs. In January 2022 a Call to Action was issued to audiologists across Ohio to participate in the revision process of the diagnostic protocol to reflect JCIH (2019) recommendations. What follows is the revised diagnostic protocol.

# Substantive Changes

- Removal of "Limited Diagnostic" option for testing
  - Did not require frequency-specific testing and therefore not consistent with JCIH (2019)
  - Contributed to unconfirmed diagnosis
- Risk Factor follow-up guidelines updated from 24-30 months to 9 months per JCIH (2019) Table 1
- Increased information and resources about counseling families and connecting families to services.



# Key Resource Needs



### Training/Mentorship

- Webinar to review updated recommended protocol
- Novice providers in underserved areas mentored by experienced providers



### Updated equipment

 Some facilities reported limited or no access to diagnostic ABR equipment able to complete frequencyspecific testing



### Administrative support

 Some facilities reported limited administrator support for training, equipment, scheduling time, etc.









# Participatory Partnerships

 Collaboration of partners from any area of expertise, provided that the expertise is seen as useful to the community. Being fully committed to a partnership of equals and producing outcomes usable to the community.











### Participatory Partnerships

- EHDI + Community Provider Expertise =
  - Statewide protocols
  - Training programs for all Ohio Audiologists
  - Strengthens PDSA cycles











# Sustaining 9 years of Progress...

- Welcome all collaborators and set expectations for participation
  - Understand when collaborators must decrease or increase their participation at different times
- Choose projects that are meaningful to the group and have measurable outcomes that you can monitor and share

### **Future Directions**

- Continued support for the COACH Protocol
  - Request pending for Infant Hearing Screening Subcommittee (IHSS) to endorse updated protocol
  - Provide training and mentorship to increase access to evidencebased diagnostic assessment across Ohio
- Create Regional Networks to connect our EHDI Program
  - Establish "Champions" in NW, NE, Central, SW, and SE Ohio regions
  - Link each step of EHDI to increase completion of diagnosis and EI enrollment
