DEVELOPING THE APP

We took screening, diagnostics and early intervention and breaks them down into a series of questions. Such as:

- Parents enter state and child specific information.
- Creates reminders on the phone's calendar feature.
- Prompts at timed intervals.
- All information is held on the phone and not transmitted beyond the phone.
- Information sheet for families developed to be distributed at the hospital when a baby failed the screen.

Survey results of all hospital personnel

- Is giving the app download instruction to parents when their babies have not passed hearing screen burdensome? 100% said not burdensome at all.
