
#### **Transition**

- Audiologist refers to CO-Hear
- Attempted contact with family within 48 business hours
- Initial visit with family within 2 weeks of referral
- Referral to Community Centered Board (CCB) for direct services
- Collaboration with CCB service coordinator
- Assessment and initial IFSP for direct service provider.
- CHIP Facilitator (DHH specialized direct service provider) provides services
- CO-Hear provides mentoring, support, and trainings
- 2 years, 3 months
- Collaboration with Child Find Evaluation Teams

	Referrals for both Unilateral and Bilateral hearing differences are sent to the CO-Hear from the Audiologist	All infants who are deaf or hard of hearing in one or both ears should be referred immediately to early intervention in order to receive targeted and appropriate services.
	Timely, single point of entry into the early intervention system	A simplified, coordinated point of entry into an intervention system appropriate for identified children is optimal.
	Team member for assessment and IFSP development	Early intervention services should be offered through an approach that reflects the family's preferences and goals for their child, and should begin as soon as possible after diagnosis but no later than six months of age and require a signed Part C of IDEA (Individuals with Disabilities Education Act, 2004) Individualized Family Service Plan.
COLORADO	Works with the Service Coordinator for rights, follows HIPAA for all appointments and meetings, parent consent for all additional opportunities, honors parents as a valued team member	The EHDI system should be family-centered with infant and family rights and privacy guaranteed through informed and shared decision-making, and family consent in accordance with state and federal guidelines.

# **Aligning with JCIH and Best Practices**

CO-Hear Role	JCIH Recommendations (2019)
Provides parent packet, manual, and ongoing information about resources, programs, supports (regionally, statewide, and nationally)	Families should have access to information about all resources and programs for intervention, and support and counseling regarding the child's educational and communication/language needs
FAMILY Assessment at regular intervals to assess whole child development, training and mentoring of CHIP Facilitator, access to additional assessments	Professionals with appropriate training should provide ongoing surveillance of communication development to all children with or without risk indicators.
CHIP Facilitator provides weekly services, trained and mentored by CO-Hear, access to additional resources	Appropriate interdisciplinary early intervention programs for identified infants and their families should be provided by professionals knowledgeable about the needs and requirements of children who are deaf or hard of hearing (JCIH, 2013)
Scope and Sequence for CHIP Facilitators, padlets to access resources, ongoing workshops and trainings related to best practices, conversations at reviews and annuals to ensure families are being "served"	Early intervention programs should recognize evidence-based practices and build on strengths, informed choices, language traditions, and cultural beliefs of families they serve

#### **Benefits to the Family**

- Primary EI specialist to coordinate, collaborate, and support throughout the evaluation/IFSP process and beyond
- Knowledgeable about local and regional resources and programs
- Helps ensure best practices are being implemented
- Provides unbiased information about communication modalities, therapy options, program opportunities, etc.
- Consistent person through the early intervention journey
- Provide professional development opportunities for CHIP Facilitators
- Share additional community events and opportunities
- Access to speciality providers as need (AAC, LSL, ASD, VCSL, etc.)
- Family connections

- CHIP facilitators receive quality mentorship in their field of expertise along with ongoing training opportunities to ensure they are implementing best practices as outlined in the JCIH guidelines
