# Transition from identification to early intervention: capacity and sustainability

- Single point of entry: Inter-agency collaboration between specialty service coordinators and Part C Service Coordinators
- Review current virtual contact with families; prepare for potential shift to in-person or hybrid
- Roles for children with established conditions (e.g., bilateral hearing differences) and children with UHL

#### Early Intervention

- Integrate best practices for transition from Part C to Part B into El Colorado's system
- Professional development
- Aligning assessment of child outcomes among CU-Boulder/CSDB and CCBs

# Colorado EHDI Alliance


- 18 *invited* members from State agencies and community

# **Build Consensus**

### Steps in the Consensus Process

- Thorough dialogue & subsequent analysis of issues until all members feel sufficiently informed
- Decision making undertaken when the group identifies they are ready
- ► Acknowledge each person's perspective:

- ▶ If there is even one "thumbs down", the group continues to dialogue about the issue and attempts to resolve it
- ► A decision is made when all participants can provide a thumbs-up or thumbs-sideways

Be objective: use data to assure decisions are evidence-based

Avoid ideological battles; work toward consensus

Rely on State law(s) and best practices

Share: data, ideas, communiques

Be sensitive to the reader/listener/signer

Develop systems for transition points

Remember our audience: This is for the kids and their parents

Everyone has biases. acknowledge them; be aware of which voices are not yet being heard
