


# Our motivation: JCIH Goal #3

  - Idaho's Tuesdays at 10:00 has evolved into Wyoming's 1st and 3rds
  - Maine and New Hampshire have begun developing a parent opportunity



### Plan for Cross-State Collaboration

1

Identify and connect with neighboring states to establish collaborative efforts

2

Identify the professionals and "resources" each state has to support the collaborative effort (funding sources)

3

Gather data from a needs survey\*

4

Use the data to start planning the collaborative effort (e.g topic, presenters, day/time, costs, etc) 5

Provide event/training and gather feedback to determine effectiveness



# **Determining Training Needs**

#### **Survey for WY Early Interventionists**

- 1. Daily listening checks and understanding/troubleshooting amplification devices
- 2. Understanding a child's hearing loss and the potential impact on development
- 3. Creating listening opportunities in consideration of the auditory skill hierarchy
- 4. Strategies to increase verbal responses and expressive language
- 5. Strategies to increase receptive language
- 6. Strategies to increase early literacy development
- 7. Strategies to increase gesture use and play to develop language
- 8. Strategies for music, singing, and nursery rhymes
- 9. Strategies to incorporate coaching during sessions and promoting daily routines
- 10. Identifying a family's strengths and learning style to improve outcomes

## Have we been successful?
