Brief overview: Laws to Know

Laws to Know

- IDEA = Individuals with Disabilities Education Act
- 504 = Rehabilitation Act of 1973 (federally funded)
- ADA = Americans with Disabilities Act
- Federal Regulations for each law
- State Special Education laws all different

	Name of law	IDEA	Section 504	ADA
	Applicable age	Birth to 21 years old	Any age	Any age
	How to get the law's protection	Must "qualify"	Disability that substantially limits a major life activity	Identifiable disability or regarded as so
Laws	Applies to who/what?	Local, state and federal	Entities receiving federal funds	Public accommodations and private entities
view	Who decides?	IEP team	504 coordinator	Upon request or see need
	Goal of law	Specialized education	FAPE and accommodations	Reasonable accommodations
Chart developed by Holmes Hlibok, Esq. @NAD	Measure of law	"educational benefit- a year's progress"	"appropriate accommodations"	"effective communication"
	Can compare?	No comparison- individualized	Compares to other disabled students	Compares to hearing student

Important Distinguishing Points

- Each law is separate and must be applied separately (504 is very connected with ADA, state/federal/private)
- Section 504 Plan can use with or without IDEA
- Some schools will try to give ONLY 504 Plan
- Very similar to Section 504, but not part of planning
- IDEA and 504 are part of plan between schools and parents, not the ADA
- But schools must comply with the ADA, and are liable for \$\$\$ if not (Perez v. Sturgis Public Schools)
- What works for each child is different
