### How I Got Started...

In June of 2020, my granddaughter, Bella was born at home with the help of a midwife

Hearing screening options at the time were hospital or clinic

Bella's hearing was screened in the comfort of her mother' arms, at home

Maybe there are other families who would love to have NBHS their homes too?



## Newborn Hearing Legislation

HB18-1006 (1997;2018): NBS & NBHS are mandated by law

Code of Colorado regulations: 6 CCR 1009-6: newborn hearing screening (effective March 16, 2020).

Midwives and birthing centers are also required to either screen babies for hearing loss or provide information to parents on where to obtain a newborn hearing screening.



### Quality Improvement And Evaluation Of EHDI Programs

Applied at each level of the program, including: •

- The overall state EHDI program.
- Individual hospital and birthing center programs.
- Home births.
- Diagnostic and intervention programs (pediatric audiologists, amplification, cochlear implants).
- Tracking and surveillance programs.



### RESEARCH

Is not my responsibility (91.1%) Lack the resources & knowledge to guide families (92.9%). They did not know what to say (47.1%) They had to deal with other more pressing issues (43.9%)

- Wild Birth
- Unassisted Birth
- DIY Birth
- Unhindered Birth
- Lay Or Traditional Midwife Assisted Birth (Illegal In Most States)
- Doula Assisted Birth (Similar To Lay Person)
- Midwife Assisted Home Birth
- Birth Center
- Hospital Birth With Midwife
- Unplanned Home Birth (Home, Car, Roadside)\*



### Understanding Midwives

- Certified Nurse-Midwife (CNM)
- Direct-Entry Midwife (DEM)
- Certified Midwife (CM)
- Certified Professional Midwife (CPM)
- Lay Midwife/Traditional Midwife
- Midwives work in hospitals too




### Goals


- 1. Can we increase the number of home birth families receiving a NBHS?
  - a. Currently, about 30%
- 2. Can we reduce the number of
  "Outstanding Missed on Initial
  Screening" on the CDPHE list by at
  least 50%
  - a. Approximately 1000 babies per year lost to follow-up

#### Total NBHS Screening for NorthStar Audiology







#### NBHS Screening Collaboration Pilot Project

### **NBHS Screening Data**






#### **Colorado NBHS Missed Trend in Years**

### Goals Met?

- 1. Can we increase the number of home birth families receiving a NBHS?
  - a. Yes, about 92%
- 2. Can we reduce the number of "Outstanding Missed on Initial Screening" on the CDPHE list by at least 50%.
  - a. Yes (40%)



### Challenges

- 1. More education is needed for home birth families and midwives
- 2. Not all midwives are onboard with NBHS, referrals, or data entry
- 3. Not all midwives have access to equipment or screening services
- 4. Funding
