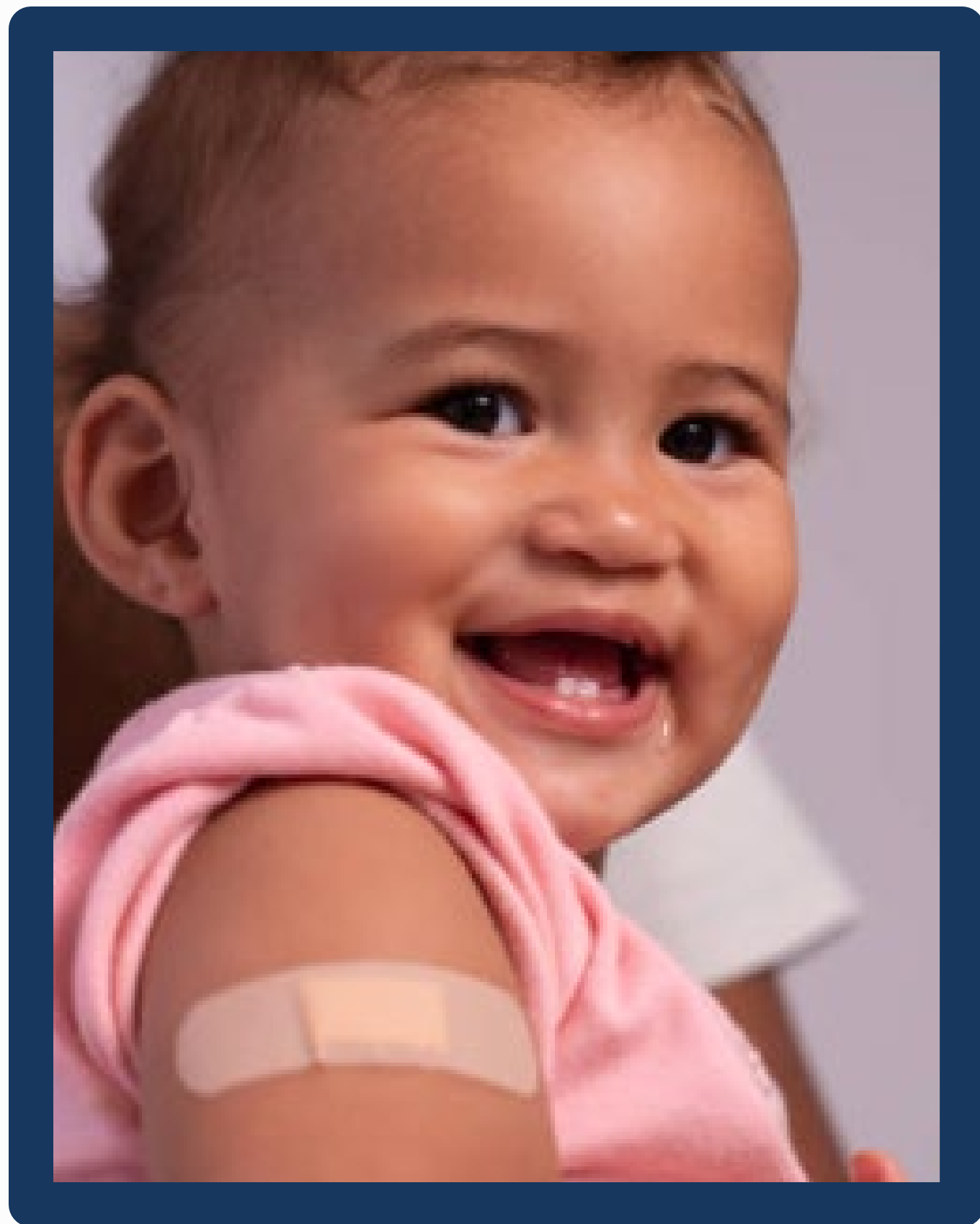

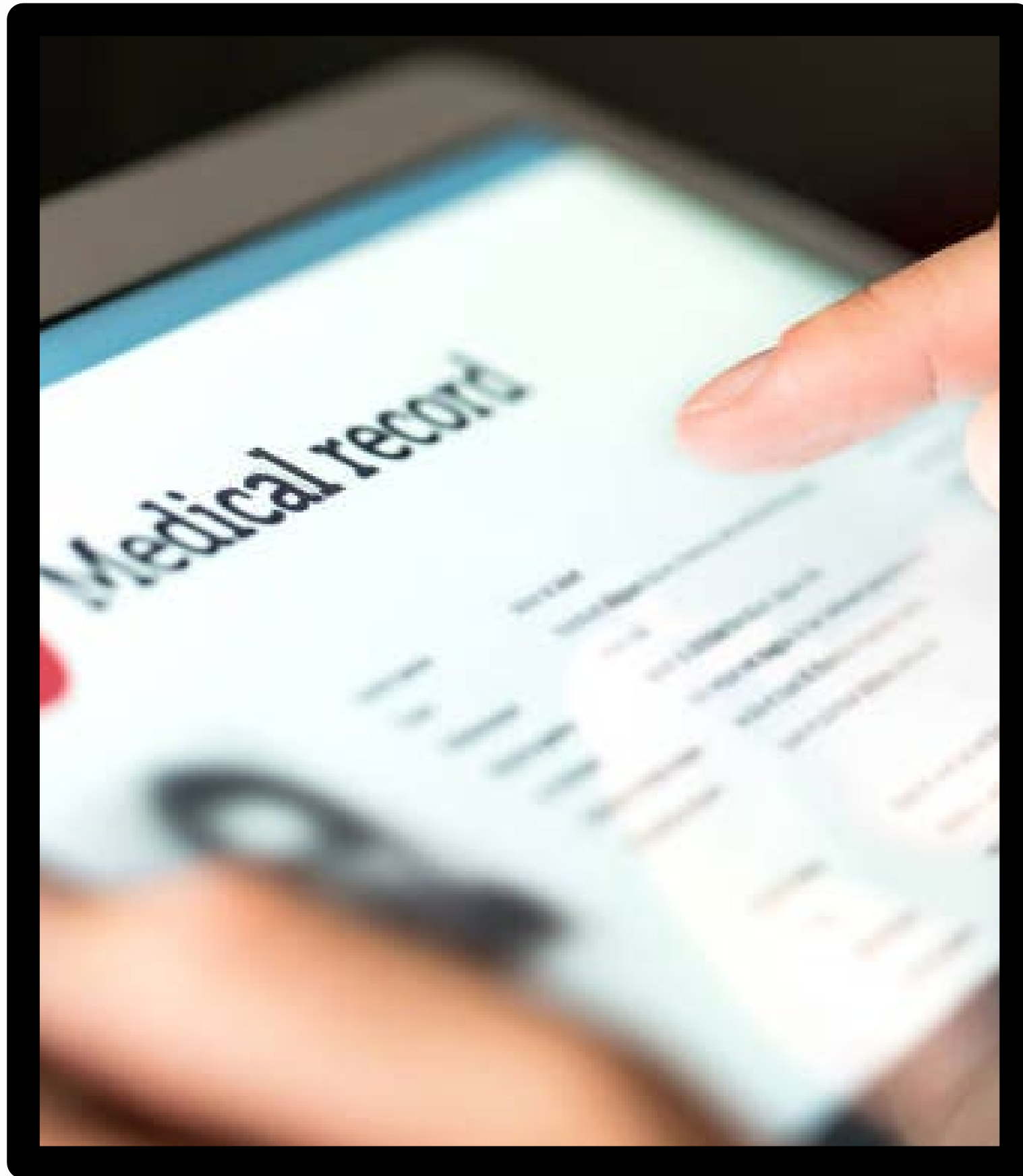

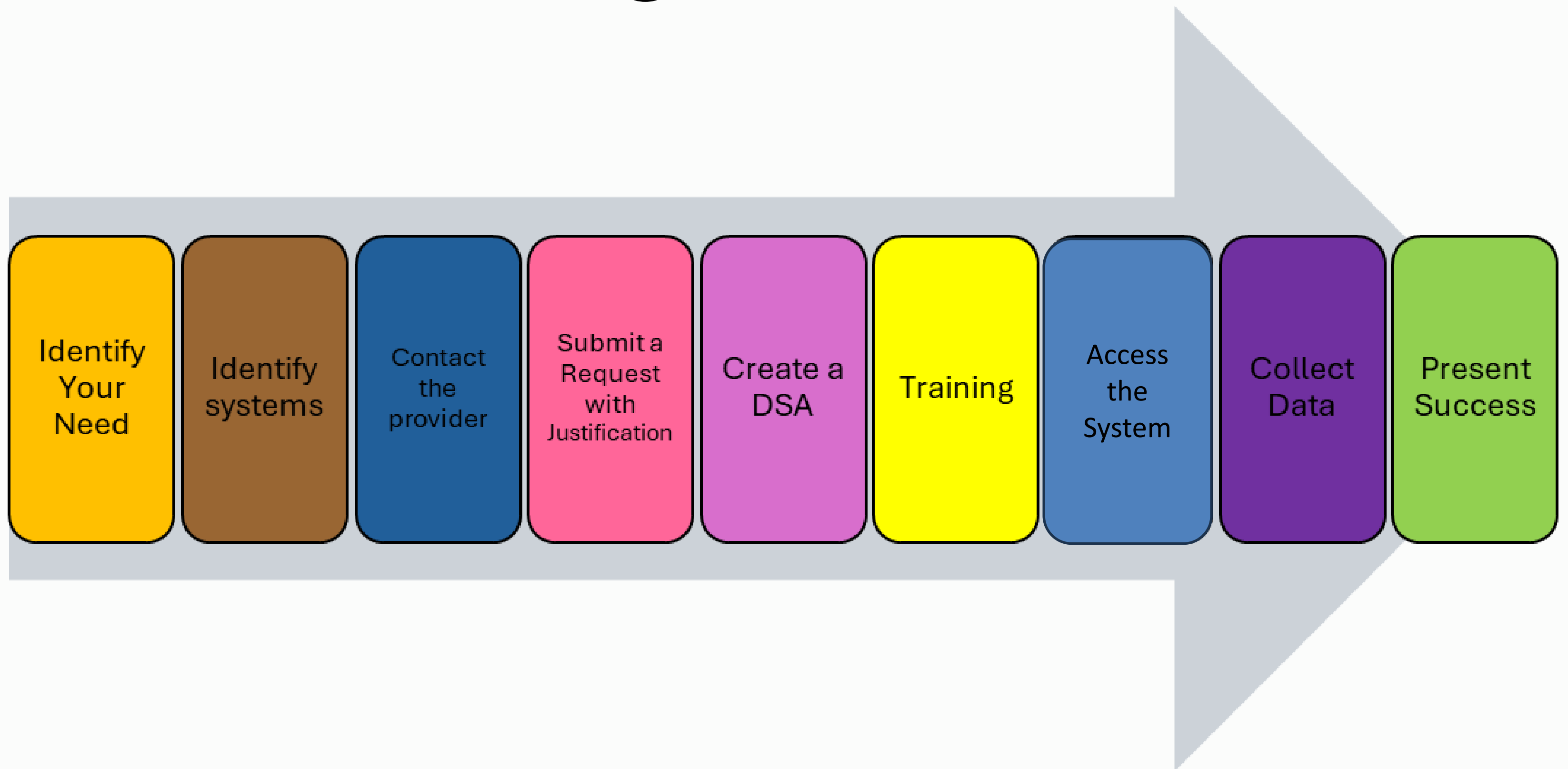

Advantages

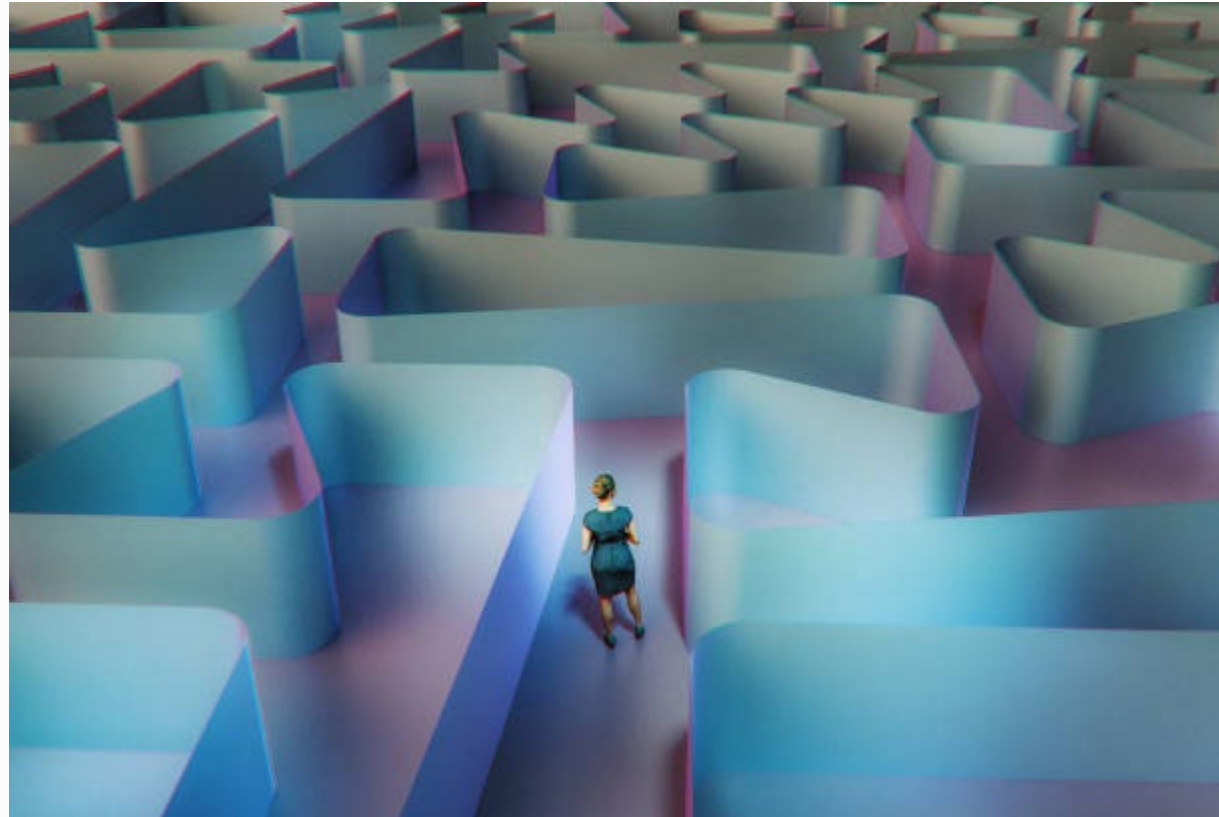
- Improved Tracking and Data Management

- Instant Information at your fingertips



Disadvantage

Data in HIS is only as good as what is entered into that system.
