## **cCMV Screening Legislation**

Section 383.145, Florida Statutes, requires:

- Targeted point-of-care cCMV screening, beginning January 1, 2023, for infants who do not pass the newborn hearing screen.
- Expanded cCMV screening to additional at-risk newborns, beginning July 1, 2024.



# **cCMV Screening Legislation**

Hospitals are required to:

- Screen newborns who fail the hearing screen.
- Screen newborns born before 35 weeks gestation.
- Screen newborns with an anticipated neonatal or cardiac intensive care unit stay of 21 days or longer.
- Screen newborns transferred to another facility for a higher level of care.
- Report results to the Department of Health (DOH) within seven days of receiving result.




## **cCMV Screening Data**

January 1, 2023 – December 31, 2024, Florida:

- Screened 28,000 newborns.
- Identified and followed up on 250 cCMV positive newborns.
- Conducted outreach and support to:
  - Hospitals: 110
  - Primary care physicians (PCPs): 5,500
  - Pediatric audiologists: 350

# **cCMV** Screening

Identification of:

- The hearing screening prompt.
  - First or second failed inpatient hearing screen.
- The cCMV screening test type.
  - $\circ$  Saliva or urine
- Confirmation of cCMV positive screens.
- Communication of cCMV results to the primary care physician.

## **cCMV** Follow-up

Follow-up procedures for newborns who test positive for cCMV:

- Early Hearing Detection and Intervention (EHDI) Program staff contact the neonatal intensive care unit or the newborn's PCP.
- EHDI staff refer newborns diagnosed with cCMV to the Florida Part C program.
- EHDI staff continue follow-up for infants who do not pass their hearing screens until a diagnosis.



# **cCMV Referred Hearing Follow-up**

Follow-up for cCMV positive newborns with a failed hearing screen:

- EHDI staff follow family for 3–6 months to ensure audiology appointments are set and kept.
- EHDI staff request diagnostic reports to assist families in making informed decisions about the next steps.
- EHDI staff continue follow-up for infants who are diagnosed with a hearing difference to support families.




# **Provider Support**

Quality improvement and provider support includes:

- Hospital outreach:
  - Monthly hospital reports
  - Data-driven technical assistance
  - On-site and virtual visits
- PCP follow-up:
  - Daily results checks
  - o Referrals
    - Confirmatory testing
    - Infectious disease
    - Audiology surveillance

#### **EHDI Advisory Committee, Early Adopters, and Innovators**

Advisory Committee members, early adopters, and innovators collaborated with EHDI on:

- Developing guidelines prior to implementation.
- Presenting webinars to engage early adopters and innovators of cCMV screening.
  - Discussed procedures and answered implementation questions.
- Connecting innovators together to expand on previously developed advancements.



# Hospitals

EHDI engaged hospital stakeholders through:

- Provision of educational webinars.
- Creation of a cCMV web page on the <u>Florida Newborn</u> <u>Screening</u> website.
- Provision of general and individualized technical assistance and data-driven support.



# **PCPs and Audiologists**

EHDI engaged PCPs and audiologists through:

- Individualized communications with PCPs regarding recommendations for newborns identified with cCMV.
- Individualized communications with audiologists on ensuring timely and continuous follow-up for newborns identified with cCMV.
- Development of targeted PCP and audiologist educational letters.



### **Families**

EHDI engaged families through:

- Targeted follow-up
- Referrals to Florida's Part C Program
- Letters:
  - $\circ$  Support and next steps
  - $\circ$  4-month reminder
